6. Reservation:-

- **a)** Local and Non local reservations will be followed as per guidelines Rule of Reservation will be followed as per rules in vogue. Evaluation of various physical disabilities and procedure for certifications will be as per order contained in G.O. Ms.No. 56 WD,CW&DW(FW) Dept. 02-12-2003 & G.O.Ms.No. 31 /WD,CW &DW(DW) dept. dt. 01-12-2009.
- **b)**Reservation to Local Candidates: Reservation to the local candidate is applicable as provided in Article 371-D as per G.O. Ms.No. 674,AG)SPF-A) Dept. dt. 20-10-1975 and rules amended from time to time and as in force on the date of notification.
